K107'S "DARYL HALL TICKETS" CONTEST OFFICIAL RULES

Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

4. **Winner Selection.** On or about 10:00 am ET on February 22, 2025, Station will select four (4) potential winners in a random drawing from among all valid entries received by Station during the Contest Period.
